



Grenfell environmental checks: joining instructions to attend a virtual community event on Monday, 20 July at 11am to 12 noon

What is the event for?

This is an opportunity to meet the scientists who are carrying out, supporting or overseeing Stage 2 of the environmental checks around the Grenfell Tower site. You will be able to find out more about their roles, what has happened so far and what will happen next.

You will then have the opportunity to ask any questions you may have about the environmental checks during a question and answer session.

How do I take part?

The event will be hosted on Microsoft Teams Live Events. To take part you will need a desktop or laptop (Windows or Mac), tablet or phone (Android or iOS) with access to the internet. You will also need up-to-date versions of Chrome, Edge, Firefox, Safari, or Internet Explorer 11, as well as speakers or headphones.



How do I ask a question?

If you would like to ask a question during the event, please follow the steps below:

- 1. Go to the 'Q&A ⁽²⁾' button, which you will find on the right-hand side of your screen.
- 2. Type your question in the compose box, and then select **Send**. If you want to ask your question anonymously, please select **Ask anonymously**. See on the next page:



- **3.** You don't have to wait until the question and answer session to send in your question.
- **4.** Once you have sent in your question one of the scientists will respond to it during the question and answer session.
- **5.** If there are several questions that are the same or very similar the scientists will give a single response during the question and answer session.

What if my question isn't answered?

We have allowed 30 minutes for the questions and answer session. We hope this will be enough time to answer all your questions on the environmental checks.

Should we run out of time your question and the answer will be included in a question and answer section in the next environmental checks community update.

If there is a specific question that the scientists are unable to answer during the event it will also be included in the community update.

What if I can't attend on the day?

If you are unable to attend on the day, a video of the event will be posted on <u>www.youtube.com/mhclg</u> and we will share the link once it's available.

Following the event, a community update, including a question and answer section and the presentation from the event, will be shared.

There will also be opportunities to meet the scientists and ask them questions at further events during Stage 2 of the environmental checks.
