WATER RATES

We have had several enquiries regarding the switchover of water rate payments from RBKC to Thames Water. You should by now have received water bills directly from Thames Water covering the period September19-March 2020, if you feel your bill is to high contact them directly to query the bill. If they cannot prove how much water you use they must put you on the lowest tarrif. If you are in receipt of benefits you are entitled to a discount under the Sure start scheme. NORTH KENSINGTON RESOURCE CENTRE

We are aware that the Grenfell Nursery staff and the consultancy firm Fluid carried out a doorknocking exercise on Hurstway, Testerton Barandon walkways.

The exercise was used to get resident feedback for the proposal that the Resource Centre between Hurstway and Testerton Walk's be demolished and, in its place, a state-of-the-art nursery with space for 40 children be built. Along with this there would be a dedicated community space. The drop-in service that currently runs there would then move back to Lower Clarendon where the nursery currently resides.

We are still unclear as to why there was no mention in the consultation of what alternatives have been explored. The RA wants very much to support the Nursery but appreciates that a great deal of disruption will result from redevelopment particularly for those who immediately overlook it and their concerns should have particular importance. It is possible that yet another consultation (yes, we know, not another one, aaaggh!) will be needed in which more information should be forthcoming. We have asked a number of questions of the drop-in service regarding usage figures of residents of the estate, but this information has not yet been received.

The agreement for use of the premises was extended for 1 year under the previous Lancaster West Residents Association committee and this is now up for renewal in November.

LEASEHOLDERS

Dear Leaseholders,

Since it has been a while since we last met or communicated I thought it would be good to update you all on where we are and what the council are offering to us.

The original budget for the refurbishment agreed by the council was for £30 million of which £15 million was from a Central Government grant and not liable to be recharged.

Following a successful meeting of Government ministers with the RA, the MGCLG made a further grant of £9.9 million and the council agreed to put in a further £18 million.

The maximum recharge to leaseholders on money funded by the council is capped at £15,000 over 5 years under the Social Landlords Mandatory Reduction of Service Charges (England) 2014 Act (or Florrie's Law). The council have acknowledged this and offered a discount of 20% on work not covered by the grants to all resident leaseholders, which they define as leaseholders who live in their property as their primary residence and we have been assured that will include part-ownership. They have also offered the possibility of easy payment terms or as a charge on the mortgage of the property if it is sold.

Obviously we want this to go further, why should we pay for the works we paid for years ago would have never have happened without the fire? We are working to get further grants of £20 million loans to allow us to have a state of the art, environmentally friendly green heating system for the estate which would all be exempt from recharge to the leaseholders. It is also possible to structure the works so they are either considered as improvements which are exempt or that they are covered by the Government Grants. The council have also agreed to pay for independent legal advice for us.

Nothing definite has been agreed about the leaseholders yet and the council say they are open to listening to us. We will be meeting in the next two weeks to discuss strategy and organise our next steps.
