ANNUAL GENERAL MEETING - POSTPONED

The RA was due to hold elections and the AGM on 25th an 26th March. When the nominations closed on the 5th March 2020 nine residents had nominated themselves.

There are 15 seats on the committee, so since there were fewer nominations than the number of seats, there was no need to hold an election. The outgoing committee stood down on 26th March and the new committee has taken over and elected the officers:

This process would usually take place at the AGM however due to COVID-19 and following government advice the AGM has been postponed until further notice. As soon as it is safe to do so the AGM will go ahead.

The RA have also taken the decision with immediate effect to close both the Lancaster West Community Centre and the North Kensington Resource Centre.

ANNUAL REPORT

Community Centres

Lancaster West Estate Community Centre

In July 2019 the RA signed a management agreement with RBKC to take over the running of the community centre on Station Walk. Since taking over the centre the RA asked RBKC to refit the kitchen and replace the flooring both of which have now been completed.

Several organisations asked to use the centre to run projects and it was agreed that if the project could directly benefit the residents then the space could be used.

The Notting Dale Community Champions run a weekly group **Baby and Me** which is a music session for mothers and babies and has been extremely well attended alongside their baby massage sessions. Age UK had the champions have also run a great chair-based exercise for our older residents, this session rotates between different centres every few months.

Eunicia Harding and the team from **RISE**: Eleanor, Prisilla & Rhumel, have been running an after school club three day a week since September which has over 20 children registered. The club is currently funded by the People's Health Trust. This club is unique in the area as the children are collected from three local primary schools, on arrival receive a home cooked meal and snacks. The children take part in a variety of activities which include, Homework club, arts and crafts, music dance, one to one support, reading sessions and meditation. The club has been supported by some wonderful resident volunteers including Natasha Gordon who was involved with the forming of RISE after the Grenfell fire tragedy, Omagh Gommari and parents Bashara and Daniella.

This month Eleanor and Rhumel have said goodbye for new pastures and we thank them for all their hard work. The team have welcomed Marlon who is a youth worker with years of experience, and we know he will be a great addition to RISE and the afterschool club.

We would also like to take this opportunity to thank Eunicia and the team for their outstanding contribution to the children on the estate; and congratulate them on their success in receiving funding from the Grenfell Project fund which will see them take over the afterschool club from September, with the intention of running five days a week. We wish Eunicia every success with her new venture.

The community centre has also been used by several residents for family functions, a home school group, Grenfell Recovery college, Grenfell United and Grenfell Trust since last August and all have praised the centre for being such a lovely venue.

North Kensington Resource Centre

Over the last few years, the centre was used solely by the LWCN Stay and Play service. At the request of residents the RA started to run two projects at the centre with Jacquie Haynes on a Friday.

Stretch with Jax is a group of residents meeting for a very informal stretch session every Friday morning followed by Breakfast club funded by the People's Health Trust where residents can have a healthy filling breakfast prepared by Jacquie and our Community Development Co-ordinator Fiona.

We have also used the centre as a base for a new music session, which is open to residents of all musical abilities and are over the age of 16.

Jacquie Haynes continues to use the centre as a base where she regularly supports residents around housing and many other issues.

The centre is also used by residents for bible study group and will be used by a men's social group once a week in the coming months.

As of Monday 6th April the centre will return to the full use of the Lancaster West Residents. If you have any ideas for activities you would like to see please contact Fiona who will be happy to look for funding to support activities. The centre is also due to be painted w/c 13th of April, however this may be postponed due to the current situation with the COVID-19 outbreak.

The RA has temporarily closed both facilities as of 19th March in accordance with Government advice on COVID-19, until further notice.

Community Events

Family Funday

Over 350 residents attended and enjoyed a variety of fun activities including arts and crafts, bouncy castle, good food and music. We also had the wonderful Mr Bubbles perform his magic show and balloon modelling. Residents had the opportunity to let the RA know what they would like to see introduced on the estate at the new community centre.

Summer Camp

A very successful Summer Camp was held during the first two weeks of August for children aged 7-11 years. This was run in partnership with Lanc. West Rise Youth Group. Over 35 children enjoyed trips to the park, ice skating, bowling, a wonderful community brunch at the Curve and much more. The two weeks ended with a party where the children performed a dance they had learned over the 2 weeks.

Black History Month

Residents Eunicia Harding, Michele Active and Fiona our Community Development Co-ordinator worked together to hold a wonderful afternoon of storytelling, music and poetry to celebrate Black History Month. Local BME business owners also had the opportunity to promote their business in the indoor market that ran alongside the event. Over 120 residents of all ages attended and enjoyed a Caribbean meal prepared by Eunicia, Michelle and Fiona and an outside caterer.



The RISE team and the RA worked together to give children a truly spooky evening of scary games and fun. Over 20 children of different ages attended. The children all received a glorious cauldron of goodies to take home at the end of the evening.

Christmas 2019

Once again the RISE team, the RA and parents held a wonderful Christmas party for over 30 children, which included a very special visit from non-other than Santa himself, who once he had delivered his festive surprises stayed for a dance with the children and adults.

At the North Kensington Resource Centre Jacquie Haynes and Fiona threw a party for our older residents, which included an afternoon of music, laughter a buffet lunch and maybe a drop of very special punch. Alongside their Christmas gifts our fabulous community gardener Robert Pereno presented each resident with a plant accompanied by a beautifully performed poem.

Temporary Accommodation

The state of temporary accommodation is a national disgrace. The RA has this year attended several meetings to support individual cases as well setting up a Temporary Accommodation subcommittee. We arranged for delegates from the Archbishop of Canterbury's housing commission to visit the estate. At an open event in Clement James they met with local TA residents and visited a number of homes to see for themselves the condition that some TA residents are forced to live in. We organised a meeting chaired by the Bishop of Kensington for residents to meet with RBKC and Notting Hill Genesis to discuss the failings to properly support our TA residents and several actions have been agreed upon moving forward.

We have also negotiated that residents in TA will have their repairs dealt with by W11 Neighbourhood Team where possible.

Refurbishment

Back in July 2017 the Council committed to making Lancaster West a "model for social housing in the 21st Century. Finally, there is a major part of the money available for them to keep their promise. More is still needed as was identified by RBKC in costing the needs identified in the Books of Ideas produced in April 2018.

In July 2019 the RA was pivotal in negotiations to secure an extra £27.9 million to add to the £30million promised by the Government and RBKC. There is enough money to ensure that ALL Council tenanted flats on the estate can be done up to a high specification. There will be new windows, fully controllable heating and improved water pressure (both hot and cold). Also new kitchens and bathrooms.

More money will be needed to provide an energy system which would ensure that all our bills can be reduced, disabled access can be improved, and the common parts can be made attractive and welcoming. The RA is working alongside the W11 Neighbourhood Team in seeking funding from BEIS and there are projects that have received some funding to evaluate ideas that would best suit the estate.

We will need to continue to fight to ensure that everything is delivered, and that the process is carried out sensitively. This means that all possible help will be sought from the Council to minimise any disruption.

Leaseholders

We all know that the current situation will have enormous impact for all of us.

Specifically for leaseholders the government have promised that all people affected by the Coronavirus situation will be able to apply for a three month mortgage holiday. We have asked the council what help they will be offering to those affected and Kim Taylor-Smith has stated that they are working on what they can do. The RA has started a new section on the website for all residents at https://www.lancwest.com/information and we will be providing specific information for leaseholders as soon as we have any details.

We recently wrote to Doug Goldring, the Council's Director for Housing as many of us have received demands for enormous monthly sum to settle Service Charge bills and threatening legal action if they were not met. He has responded that they have paused sending any further letters to those in Lancaster West as the tone and manner of the letters is completely wrong. We will be working closely with the Lancaster West team to find a better way to deal with this. It is also obvious that many of the bills are wrong, indeed some leaseholders have been paying the charges all along by direct debit. We would urge all residents in the Walkways to check your bills closely, ask for a full statement of accounts and check that the discounts have been applied correctly. It also seems that the charges may have been too high.

Doug is looking into this and we will let you know when he reports back. However, this may take a while with things as they are.

As nothing can be seen as certain at the moment and it looks as though the situation in London may be already far worse than the rest of the country. We will continue to press the council with the injustice of charging us when we have suffered so much. Now more than ever we need support from the council, not penny-pinching.



In those days the estate was not the best. I moved next door to a crack den, which was interesting to say the least and with the help of the police & the rest of my neighbours it was finally closed down.

Things began to improve on the Estate, and it was becoming no longer a no-go area, but I must admit I became a little bit apathetic to living conditions on the estate. I was a working single mother for most of it and just kept my head down and let things ride, someone else will do it kind of attitude I never even attended an RA meeting until after the fire.

I started attending the regular RA meetings and over the months I saw the numbers decline and the community cohesion beginning to wane. I began to realise that apathy was no longer an option for me.

I listened to residents sometimes complain about the RA and say things like "why aren't they doing enough " and I must admit I sometimes thought the same, but how can I judge when I'm not in their shoes, so when they asked for co-opted members I decided it was my time to do my bit, and joined the RA in 2018.

I took a break at the last election due to personal reasons and re-joined late 2019 as I felt I still had a lot to offer.

I've worked in libraries, television research for the BBC and I've been working in education for the last 26 years, and don't have any special skills as far as housing, government or council knowledge but I have learnt a lot about these over the last 2 years, and I have volunteered my time on many RA and resident led projects and events over the last 2 years, and have built relationships with some great people on the estate who I now consider friends. I am committed to doing what I can when I can to make the estate a better place to live for now and in the future.

For things to change and improve, we must all do our bit, and I'm willing to do my part not just for me and mine but for all of us.




- Continuing the fight for our neighbours who have been in "Temporary" Accommodation for an unacceptable amount of time, and to improve the condition in which they are living.
